

About the Zika Virus

A mosquito bite can give you Zika. Zika is a virus that can hurt your pregnancy. The virus during pregnancy can cause birth defects. Your baby could be born with microcephaly. This is a serious birth defect of the brain. Other defects of the eyes and hearing have been reported.

Zika virus can be transmitted through sexual contact. Use condoms or avoid having sex.

Ways to Protect Your Family

- Dump standing water around your house. Mosquitos lay their eggs in water. Turn over or cover all outdoor things that can hold water.
- Use window and door screens.
- Wear long sleeved shirts and long pants.
- Use mosquito repellant.* Pregnant and breast feeding women can use repellant safely if the instructions on the label are followed.
- Use mosquito netting.
- Protect yourself during sex. Use a condom.

CCP Offers Free Mosquito Repellant

- Go to any in-network pharmacy that carries one of the covered mosquito sprays
- Pick out one of the covered sprays listed and bring it to the pharmacy counter
- Present your CCP insurance card
- The pharmacy will provide the covered spray at no cost to you
- You can get 1 bottle per household per month
 - Repel Sportsmen Max, 40% Spray
 Off Deep Woods, 25% spray
 - Repel Sportsmen, 25% spray
 - Cutter Skinsations, 7% spray
- Off Familycare, 15% powder spray
- Off Deep Woods Dry, 25% spray • Off Active, 15% spray
 - Cutter Backwoods, 25% spray
