PEOPLE: Meet Jodi Fredericks, Pharm.D., MBA Director, Pharmacy Services

What is your title and who do you report to?

I am the Director of Pharmacy Services for CCP and I report to Dr. Miguel Venereo, our Chief Medical Officer.



What are your responsibilities?

I oversee and administer prescription drug benefits for our Medicaid enrollees and all commercial lines of business. I manage the clinical and operational areas of pharmacy, to ensure quality and cost are managed through formulary maintenance, accurate claims processing, prior authorizations, specialty pharmacy spend, generic utilization, and optimal pharmacy contracting, with the goal of quality, cost-effective pharmaceuticals for all enrollees.

Briefly describe your previous professional experience.

After I graduated from Nova Southeastern University College of Pharmacy and received my doctorate in Pharmacy, I went to Virginia and completed a one-year residency at VA Medical Center, specializing in Ambulatory Care. Then, I returned to Florida and started working at Memorial Regional Hospital and Memorial's Primary Care Centers, where I developed and ran an anticoagulation clinic and drug assistance program for three years. After that, I transitioned to Director of Pharmacy Contracting for Memorial Healthcare System for three years, and earned my MBA, specializing in Health Services Administration, from NSU Huizenga School of Business. I then served as Pharmacy & Medication Safety Officer for Memorial Healthcare System for eight years.

Why did you choose CCP?

Having the clinical and operational experience with formulary management, pharmacy contracting, and cost savings initiatives for a healthcare system, I wanted to expand my experiences to the managed care arena and broaden my horizons, and this was the perfect opportunity to do so and help create a pharmacy program for CCP.

Our 2017 Security Awareness Week took place from April 24 – 28 and was filled with important information shared by our IT team at daily Lunch & Learn sessions. Below, we share tips from Kevin Farber on Malicious Email Attachments:



Malicious Email Attachments

Email attachments are a way for a sender to transmit files to another user via email. In a similar way to junk mail coming to your door at home, email users regularly receive unsolicited emails from unknown senders. These emails can often contain links to malicious web sites or have attachments containing malicious software.

How do you recognize it?

A suspicious or malicious email attachment is typically received from an unknown sender. The subject line or the email body usually contains a "special one-time offer" or a "call to action" to induce the recipient to open the attachment.

What risk does it pose?

If you open a malicious attachment, it could result in a number of undesirable outcomes, such as installing a key logger to record your keystrokes, installing a virus, or even providing an intruder with remote access to your computer.



What to do if I opened a malicious attachment?

If you suspect that you have clicked on a malicious attachment:

- Immediately disconnect the computer from the Internet
- Scan your machine with up-to-date anti-virus software
- Do not input any sensitive information into the machine until the anti-virus scan is passed

How can I avoid it from happening?

- Keeping an anti-virus product installed and up-to-date is the best defense against malicious attachments
- As a general rule of thumb, you should never click or open an attachment which seems suspicious, in any circumstances, even if it is from someone you know

Top Tips

- Be suspicious of any email attachments from unknown sources or with offers that seem too good to be true
- Never open an email attachment you are unsure about
- Keep an anti-virus program installed and up-to-date




