HEDIS 2017

The Healthcare Effectiveness Data and Information Set (HEDIS) is a tool used to measure performance on different dimensions of heath care and services given to Patients. HEDIS measurement guidelines are standardized by National Commission for Quality Assurance (NCQA).

HEDIS categories ranges from newborn to adulthood for preventative screenings, annual well visits, immunizations, chronic disease management, behavioral health care, prenatal/postpartum care, and access to care.

Data collection can be calculated administratively (claim codes) or by Hybrid (Claims and Medical Records Data). CCP has hired Inovalon for HEDIS data record collection.

CCP MMA Medicaid Plan Expanded Benefits Provider Notice

Community Care Plan (CCP) is committed to a continuous review and maintenance of services and benefits to ensure our members receive the best possible care to manage their health.

Newborn Circumcisions Expanded Benefit

CCP is pleased to announce the benefit of newborn circumcision within the first 12 weeks of birth (84 days) has been approved by AHCA and reimbursement increased.

- An authorization will not be required as long as service is completed by participating provider.
- The CPT codes to cover through 84 days are 54150 / 54160 / 54161.
- Providers are paid new rate of \$300, effective January 1, 2017.

CCP MMA—Access to Rho (D) Immune Globulin for OB Patients

- This is a covered benefit by CCP at no cost to the OB patient.
- OB Clinician may bill Rhogam through the medical benefit with no J code prior authorization needed, or may prescribe HyperRho through pharmacy benefit using specialty pharmacy.
