SUBJECT: COVID-19 State of Emergency: Vaccine Administration

Community Care Plan (CCP) remains committed to ensuring that Medicaid recipients receive care that is medically necessary to prevent and treat the 2019 novel coronavirus (COVID-19). The purpose of this alert is to detail Medicaid's coverage of the new COVID-19 vaccines.

Eligible Enrollees and Exclusions

CCP will cover the COVID-19 vaccine administration for all enrollees, including those residing in facility-based settings (e.g., nursing facilities, assisted living facilities, etc.).

CCP is not responsible for reimbursement of the COVID-19 vaccine administration for enrollees with Medicare or commercial insurance.

The Florida Medicaid program covers the COVID-19 vaccine administration by age, as specified in the Food and Drug Administration Emergency Use Authorization approval for each vaccine product.

Prior Authorization

Prior authorization is not required for the COVID-19 vaccine administration or product.

Co-Payments

Co-payment requirements are waived for all COVID-19 vaccine administration and products, including co-payments for a physician office visit at which the vaccine is administered.



Eligible Providers

CCP will reimburse Medicaid-enrolled providers for the administration of the COVID-19 vaccine to our Medicaid enrollees, for any place of service, and without regard to whether such services are provided by a participating or nonparticipating provider, such as:

- Physicians and physician extenders, including those practicing in a County Health Department, Federally Qualified Health Center, or Rural Health Clinic.
- Pharmacies for COVID-19 vaccine administration rendered by a pharmacist.

Billing & Reimbursement

Effective December 17, 2020 and retroactive to December 11, 2020, CCP will cover the COVID-19 vaccine administration as indicated in the Eligible Enrollees and Exclusions section above. CCP must complete all necessary system programming for the processing of claims related to the vaccine administration codes by January 18, 2021.

Since the COVID-19 vaccine is currently available at no cost through Medicaid’s Operation Warp Speed, CCP is not responsible for reimbursement of the vaccine product at this time. Vaccine administration codes and fee-for-service delivery system rates for physicians, physician extenders, and pharmacy providers are provided below:
